## GENERAL INFORMATION AND NOTICES

This Bulletin is published by the Registry of Industrial Designs in accordance with the Section 21 of the Industrial Property Act of Kingdom of Bhutan, 2001 and Rule 34 of the Industrial Property Rules, 2001.

### **Section 21 (IP Act of Kingdom of Bhutan, 2001)**

#### **Examination; Registration and Publication of Industrial Design**

21. (1) The Registrar shall accord as the filing date the date of receipt of the application, provided that, at the time of receipt, the application contains indications allowing the identity of the applicant to be established and the required graphic representation of the article embodying the industrial design. Section 11(1) (b) shall apply mutatis mutandis.

(2) After according a filing date, the Registrar shall examine whether the application complies with the requirements of Section 20(1) and (2) and the Rules pertaining thereto, whether the application fees has been paid and whether the industrial design complies with the requirements of Sections 17 and 18(3) and the Rules pertaining thereto.

(3) Where the Registrar finds that the conditions referred to in subsection (2) hereof are fulfilled, he shall register the industrial design, publish a reference to the registration and issue to the applicant a certificate of registration of the industrial design; otherwise, he shall refuse the application.

(4) (a) Notwithstanding subsection (3), where a request has been made under Section 20 (5) for deferment of publication, upon registration of the industrial design, neither the representation of the design nor any file relating to the application shall be open to public inspection. In this case, the Registrar shall publish a mention of the deferment of the publication of the industrial design and information identifying the registered owner, and indicating the filing date of the application, the length of the period for which deferment has been requested and any other prescribed particulars

(b) At the expiry of the period of deferment, the Registrar shall publish the registered industrial design.

## REGISTERED INDUSTRIAL DESIGN

(c) The institution of legal proceedings on the basis of a registered industrial design during the period of deferment of publication shall be subject to the condition that the information contained in the Register and in the file relating to the application has been communicated to the person against whom the action is brought.

### **Rule 34 (IP Rules, 2001)**

#### **34. Registration of Industrial Design; Publication of Reference Thereto; Issuance of Certificate**

(1) Subject to the payment of the registration and publication fee within the period prescribed in Rule 33(6), the Registrar shall register the industrial design in accordance with Section 21(3) and this Rule.

(2) The Registrar shall allot to each industrial design he registers a number in the sequential order of registration.

(3) The registration of an industrial design shall include a representation of the industrial design and shall specify:

- (i) the number of the industrial design;
- (ii) the name and address of the registered owner;
- (iii) the name and address of the agent, if any;
- (iv) the name and address of the creator, except where he has asked not to be named in the registration;
- (v) if the priority has been claimed, and the claim has been accepted, the priority date and the country or countries in which or for which the earlier application was filed; and
- (vi) the kind of products for which the industrial design is to be used.

(4) The publication of the reference to the registration of an industrial design, under Section 21

(5) shall contain the particulars specified in paragraph (3) hereof.

(6) The certificate of registration of an industrial design shall be issued on Form 6.

As per Section 23(2) of the Industrial Property Act, the request for invalidation

shall prove that any of the requirements of Section 17 and 18 is not fulfilled or if the registered owner of the industrial design is not the creator or his successor in title.

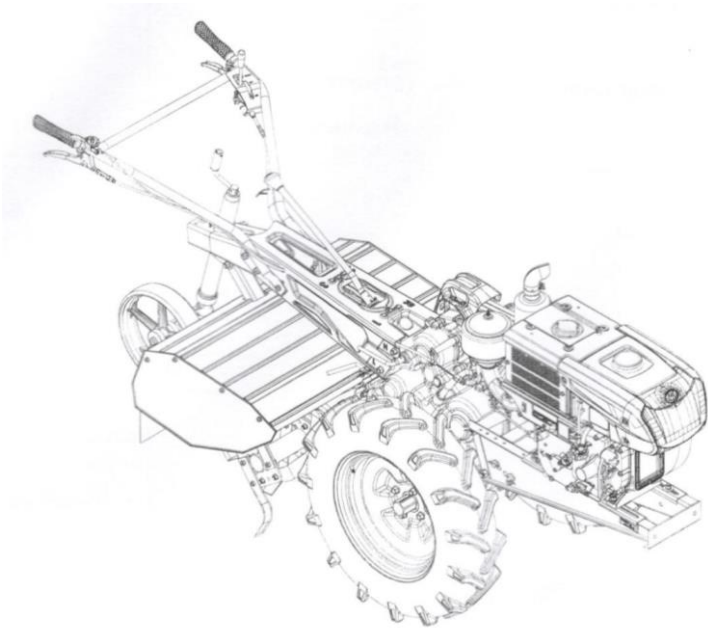
