The composition may also contain an extract of *Cymbidium erythraeum*.
The invention also regards a method for cosmetic treatment of the skin, especially as skin changes due to accelerated or chronological aging e.g. wrinkles, loss of firmness and elasticity, and increased pigmentation wherein a person's skin is treated with a composition comprising *Dionaeamuscipula* and other ingredients e.g. an extract of *Cymbidium erythraeum*.
